# Town of Ferrisburgh Selectboard Minutes October 15, 2024

## 1. 6:30 p.m. Call regular meeting to order

Clark Hinsdale called the meeting to order at 6:32 p.m.

## 2. Approve Minutes - Regular meeting October 1, 2024, Special Meeting August 20, 2024

Jim Benoit moved to approve the regular meeting minutes for October 1, 2024 as presented. Walter Reed II seconded the motion. All voted in favor. MOTION PASSED

Jim Benoit moved to approve the special meeting minutes for August 20, 2024 as presented. Chris Campbell seconded the motion. All voted in favor. MOTION PASSED

#### 3. Public Comment

Red Muir summarized the Union Meeting Hall status as covered in the Building Maintenance Report. VT Heavy Timber has resumed work and will remain on site until the roof is closed. The windows are still in progress, although delayed due to health issues. A contract extension request will likely be presented in the coming weeks as it's getting too cold to install the windows.

Red Muir stated that reading about the proposed detention center in Vergennes had him wondering about the impact on the proposed road changes for the bypass. He wanted the board to be aware he had heard discussions about Vergennes seeking a charter change. Clark Hinsdale stated he has emailed Vergennes officials to say he is willing to meet with them to discuss.

#### 4. Selectboard New Business

### a. John Bull - Highway Operations Report

Reilly LaBerge presented the following highway operations report.

- culvert work is complete
- working on pruning and ditching on Locust Lane
- working with FEMA on July storm damage
- will take delivery of new truck once loan is signed they will not be trading the old truck
- salt and sand are being brought in
- paving is underway and expected to finish this week or next and then shoulder work will be done

Jim Benoit asked Reilly to look at Cross Road where previous work was done to see if bringing in some stone will help prevent future issues.

# b. Ferrisburgh Central School as the Emergency Shelter – Chris Kayhart

Kristina MacKulin and Nikki Bearor presented what they have learned about steps needed to designate the school as an emergency shelter. Much discussion was held on what steps need to be taken, what types of emergencies, other building options, and how to proceed.

Clark Hinsdale summarized the discussion stating the Selectboard is highly interested in engaging in the process to designate an emergency shelter and partnering with the school board.

#### c. Addison County Economic Development – Fred Kenney

Fred Kenney, Executive Director of the ACEDC, provided a presentation on what his organization has done for Addison County and what they can do to help towns with economic development.

## d. Appoint Karen Petersen Interim Zoning Administrator

Jim Benoit moved to appoint Karen Petersen as Interim Zoning Administrator. Chris Campbell seconded the motion. All voted in favor. MOTION PASSED
